#### **INTRODUCTION**

This Report has been developed by the PIU in accordance with Article 12.06, Schedule A (Reporting), point 3 of the Finance Contract Serapis № 2010-0484, and reflects the evolution of Program's performance during the year 2017 and the cumulative progress from the launching of the Program in January 2012.

The Wine Sector Restructuring Program (WSRP) "Filiere du Vin" became effective in January 2012 and is scheduled to be completed in March 2019, with the last disbursement in December 2017. EIB allocated EUR 75 million for the implementation of activities initially envisaged to be implemented under the Program during 4 years with further extension for 3 years.

The WSRP aims to contribute to wine sector recovery and develop the production of bottled wines of "Protected Designation of Origin" (PDO) and/or "Protected Geographical Indication" (PGI), by (i) restructuring the wine industry, (ii) improving the quality and consistency of wine produced in Moldova from the quality of vineyards to the final packaging and dispatch of products, and (iii) diversifying the country's export markets.

In order to achieve the Program's goal and objectives Program Implementation Unit (PIU) acts through *5* **Program components, including the Program management**:

- i. <u>Winemaking enterprises development</u> upgrade the equipment and facilities, establish new winemaking enterprises, or expand the activities of the existing ones;
- ii. <u>Viticulture sector development</u> restructure and revitalize the old and un-productive vineyards, introduce new growing technologies (drip irrigation, other protection systems) and upgrade the viticulture equipment at the farm level;
- iii. Support industries enterprises development upgrade the equipment and facilities;
- iv. Laboratories, training, education and development of food security- acting through:
  - a. National Laboratories Network Development establishment / development of the relevant control bodies and testing wine quality at national level;
  - b. Education and Research Institutions support the introduction of the system of PDO and PGI for Moldovan wines; organize trainings for students; create working laboratories or update the equipment in the existing laboratories in four affiliated educational institutions.
- v. **Program management** PIU operations undertaken for the Program implementation.

The Program Components are financed through 2 *financial instruments,* which are the Credit line and Leasing, Loan guarantees being under discussion stage yet and Capital investments being practically postponed from the Program.

#### PROGRAM PERFORMANCE EVOLUTION: FINANCIAL AND PHYSICAL PROGRESS

In 2017, the 7<sup>th</sup> year of implementation, the Program continued through its activities to contribute to the recovery of the wine sector, mainly to upgrading the equipment and facilities of the winemaking enterprises and the equipment and facilities of support industries enterprises, to restructure and revitalize the vineyards and to mechanize the viticulture processes. Under the Program were made several significant steps towards renovation of laboratories of the affiliated educational institutions through endowing with new and modern lab equipment and lab furniture having as a result a more qualified specialized working force.

From the Program' start and till the end of 2017 was allocated **45,661,653.85** Euro or 60,88% from the total amount of EIB loan amount of 75 million Euros, from which the amount of **44,334,220.79** Euro was disbursed by EIB or 97,09 % from the total allocated by EIB amount.

During 2012-2017 within the Program were approved the investment sub-projects in total amount of 102,614,372 Euro, from which 45,661,653.85 euro from EIB loan and 56,952,719 euro from Final Beneficiaries own contributions, in this amount being included sub-projects implemented in the Moldovan winemaking and viticulture sectors, support industry, as well as in the education and research institutions.

During 2012-2017 from the amount of **45,661,653.85** Euro allocated by the EIB based on Allocation letters issued, the PIU received from EIB loan the amount of **44,334,220.79** Euro, from which the amount of **43,767,938** Euro was disbursed by the PIU to FBs.

The indicated amount of **44,334,220.79 Euro** was received by PIU from the EIB loan in **13 tranches** and has been disbursed to Final Beneficiaries from different sub-sectors as follows:

- for winemaking the amount of 26,610,271 Euro,
- for vineyards the amount of 3,711,934 Euro,
- for support industry the amount of 9,070,821 Euro and
- for LTEDFS the amount of 4,941,195 Euro.

During reporting period of 2012-2017 within the Program were approved 75 investment projects, from which, as is presented in the table below:

- 1. Through credit line 40 projects in amount of 76,258,489 euro, including 43,515,090 euro is EIB contribution;
- 2. Through Purchase of grapes financing 7 projects in amount of 13,907,969 euro, including 6,976,869 euro is EIB contribution;
- 3. Through Leasing operations 7 projects in amount of 4,287,610 euro, including 2,256,437 euro is EIB contribution;
- 4. Through Laboratories, training, education and development of food security 8 projects in amount of 8,160,305 euro, including 4,204,323 euro is EIB contribution;

During the reporting period of 2017, under both financial instruments provided by the Program (Credit line and Leasing operations) were approved for financing the sub-projects in the total amount of **13,483,203 euro**, from which 2,980,896 euro is the total amount of EIB allocations and 10,502,307 euro is the total amount of FB cofinancing.

During the reporting period of 2017 within the Program were approved 7 investment sub-projects: including under Credit line instrument 3 and 4 sub-projects under the Leasing operations instrument, the total amount of which is 13,483,203 Euro, from which 2,980,896 euro from EIB loan and 10,502,307 euro from Final Beneficiary own contribution.

As 2017 was supposed to be the last year during which the new allocations could be approved, PIU together with EIB experts considered it important to make corrections in allocation previously approved, these resumed from different reasons (suspension of several PFI s of participation in the intermediation of EIB funds within the Program, other specific reasons resulted in non-disbursement of approved by the EIB amount of the financing). In the following table it is presented the results of the corrections performed:

As to refer to the distribution of funds allocated by EIB under the Program by viticulture zone presented in the above table, it is worth to mention that during 2012-2017 the largest share of the investments were done by FB from viticulture zone **Codru and Valul lui Traian**, approx. **43.88** % and **42.08** % respectively, with the biggest amount invested in winemaking process modernization, rather than in viticulture

As for the viticulture zone **Stefan Voda** here were invested only **5,025 mln. Euro** or **14.03** % and again with the largest part in winemaking equipment modernization.

From the table above we also can see that during the period 2012-2017 the major amount of funds in vineyard establishment and mechanization of viticulture processes were allocated in viticulture zone **Valul lui Traian - 15,067 mln. Euro**, the bigger one than in other viticulture zones.

During <u>2012-2014</u> PIU collaborated with 6 Intermediary banks: Moldindconbank, Moldova-Agroindbank, Energbank, Banca Sociala, Mobias Banca and Procredit bank.

Unfortunately by the end of 2014 from the number of 6 PFIs the collaboration with 3 of them was postponed (EIB informed about not considering of Moldova-Agroindbank as eligible PFI for the Program anymore, as well as Moldinconbank, but with the chance of changing this status in future).

At the same time CLD postponed collaboration with <u>Banca Sociala</u> because of non-compliance with CLD eligibility criteria, this bank being liquidated afterwards.

Thus during the reporting period 2017 the financial intermediaries eligible for Credit Line financing within the Program were 4 commercial banks:

- 1. Energbank,
- 2. Comertbank,
- 3. Mobias Banca GSG and
- 4. Procredit bank.

Thus, as it is indicated in the table above during 2017, 4 beneficiaries were financed through Mobias Banca and 1 through Procredit bank.

The interest rate for the sub-loans denominated in Euro is floating, based on 6-month EURIBOR rate + 92 bps and the MoF's and CLD's margins.

The CLD interest rate for the Credit Line's resources for Euro for PFI's for the interest rates periods described below include MoF margin of 0.3 % for administrative and operating costs and margin for covering the exchange rate risk and the CLD margin of 0,3 %.

The average commercial interest rate applied by PFIs for financing "Filiere du Vin" Program's final beneficiaries in Euro besides of the Ministry of Finance margin and the Credit Line Directorate margin includes the banks commercial margin and it is determined for each FB separately, usually max 4% (the max level of margin recommended by the CLD to all PFI participating in intermediary operations of funds offered by the GoM from external credit lines).

#### B. Working capital financing within Credit Line Component

In consequence of the EIB approval of the allocation of EUR 10 million under "Winemaking" sub-sector of the FdV Program in order to support Moldovan winemakers purchase of grapes from local producers, during the 2015-2017 in parallel with "Credit line" financing of investment sub-projects through PFIs, PIU was able to propose to Program potential beneficiaries (winemakers) a new kind of financial opportunity named "Working capital" financing of grape purchase (technical varieties) through the Ministry of Finance.

In order to make the procedure as simple as it is possible, PIU have consulted all potential beneficiaries about 2 basic stages of the examination process:

- Work with PIU PB has to submit to PIU only Grape purchase contracts signed with the local grapes producers (all made due to the standardized model elaborated by TA team and approved by EIB). Based on the Contracts submitted PIU, the PIU is issuing the Eligibility Notice, confirming that the contracts are made due to the model approved by EIB and 50 % of the cumulative amount of the contracts submitted is eligible for financing under the credit offered through the MoF.
- Further, PB has to prepare the set of documents requested by MoF under the provisions of the GoM
  Decision on specific rules for on-lending operations from GoM funds and to submit it to MoF in order to
  be considered from creditworthy point of view i.e.: Business plan, balance sheet, collateral issues).

The terms applied by the MoF for this kind of financing are <u>5 years repayment period</u>, including <u>2 years</u> grace period and 3,73 % interest rate (floating interest rate).

As the result of large dissemination of this financial opportunity for Moldovan winemakers made by PIU together with MoAFI and NOVV, PIU during the reported period have received **35 Application forms** from the winemaking sector' potential beneficiaries in the total amount of **10,4 mln Euro** requested in order to finance winemakers stringent needs (purchase of grapes of technical varieties).

It worth to mention that under request of EIB experts the GFA consulting Group team performed an assessment of efficiency of this innovative instrument for winemaking and viticulture sub-sector beneficiaries of the Program. Nevertheless that Final Beneficiaries expressed the need to improve the standardized grapes supply contract, generally, all suppliers mentioned that this tool helped them to have a stronger relationship with the winery and they hope to make it even stronger with each year of cooperation.

At the same time, based on the discussions with the FB as well as based on the TA team opinion, PIU could conclude that in general, the winemakers' feedback on the working capital facility was a very positive one. Some of them reported to have increased the quantity of grapes purchased and one told to have doubled the grapes acquisition, compared to 2015.

#### C. Leasing Instrument

After launching of the Leasing Operations component under Filiere du Vin Program, during the reporting period of 2017 PIU continued to collaborate with all stakeholders and partners involved, in order to implement the Leasing operations component in the most successful way and to inform them on specific conditions, provide consultancy to SPI staff and support them to prepare internal documents on this component.

All activities after launching the Leasing instrument were based on the concept that "Leasing operations" are implemented by PIU through Specialized Partner Institutions (SPI) and can be structured in the following major activities:

- PIU continued to provide consultancy to Mobiasbanca staff and support them to prepare internal documents on this component;
- PIU continued to inform the potential beneficiaries from wine and vine sectors about the opportunity to obtain financing through Leasing operations instrument and to desire them to submit their requests to PIU in this sense;
- PIU provided consultancy to potential beneficiaries on lease terms and conditions and support them to fill in the leasing documents;
- PIU reviewed potential beneficiaries' sub-projects submitted for financing through Leasing operations component;
- For Sub-projects approved by EIB, PIU submitted to the MoF the Disbursement request from EIB loan.

As a result of actions undertaken at the reported period, PIU succeed to inform tens of potential beneficiaries, to review several sub-projects from potential beneficiaries and submit them to EIB for approval.

During the reporting period 2016-2017, under this instrument were approved for financing subprojects in the total amount of **4,287,609.82 euro**, from which **2,031,173.22 euro** is the total amount of EIB Allocations and **12,256,436.60 euro** is the total amount of FB co-financing, the amount disbursed from EIB being **419,678.22 euro**.

Therefore, Raiffeisen Leasing LLC (Moldova) will focus its activities on efficient management of the existing portfolio without allocating new funding lines, meaning that no new allocation proposal from this SPI within "Filiere du Vin" Project will be submitted. As to refer to distribution of funds allocated by EIB under the Program by viticulture zone, which presented in the above table, during 2016-2017 the largest share of the investments were done by FB from viticulture zone **Codru**, approx. 16%, where the requested financing was directed into winemaking equipment modernization.

As for the viticulture zone **Valul lui Traian** and **Stefan Voda** here were invested 43.69% and 1.23% respectively, which were directed into winemaking equipment modernization.

# **Procurement & related Monitoring Activities under the Educational Component:**

During the reported period (year 2017), PIU, in order to implement the Program Component "Laboratories, education, training and development of food security" has undertaken multiple actions that are divided into:

- 1. (A1) implementing the approved investment projects of the education and research institutions (previously approved by EIB); monitoring the implementation of previously signed supply contract(s), see if goods procured from EIB funds were in place and functioning.
- 2. (A2) assisting newly identified potential beneficiaries in investment projects development.

# A1. Implementation of EIB (previously) approved investment projects:

During year 2017 PIU has continued the implementation of the previously approved Investment Projects, for the following Final Beneficiaries: Technical University of Moldova, Vocational School Leova and Vocational School Nisporeni; National Centre for Alcoholic Products Testing (CNVCPA).

### The following activities, per Final Beneficiaries, divided by Quarters, have been performed by PIU:

# Q-1 Technical University of Moldova:

During Q1- 2017, PIU has launched a shopping procedure #FURN\_UTM3\_2017 for procuring laboratory furniture (including exhaust niches with accessories) for the last laboratory to be endowed – Laboratory of Chemistry, within Oenology Department, TUM. The requested goods were split into 2 separate lots: Lot 1 – exchaust niche with accessories; fire proof closet and Air Conditioning system; Lot 2 - Laboratory furniture;

PIU estimates the evaluation to be finished and the supply contract to be awarded and signed in Q2. It is envisaged that the supplier shall fully finalize implementing this contract by the end of Q2.

# **Vocational School from Leova:**

At the beginning of the 2017, the FB together with the PIU and selected supplier of the specialized architecture design company, continued working with SP Leova staff on preparing the design for construction of an annex to the existing microwinery hall and capital refurbishment of existing microwinery hall. As during the initial presented in Q4 design, the FB have came with the solicitation to include additionally an shop that will allow for the school to generate revenues from didactical work performed by the students, these have delayed the process of proceeding to launching a tender (combining also the FB Vocational school Nisporeni); to select the general contractor who will perform the civil works. This task is re-scheduled for the second quarter. And respectively afterwards, it shall be possible to organize a tender to select a wine equipment supplier to supply the necessary wine making equipment, thus, the microwinery laboratory of FB to be fully endowed for education purposes.

## **Vocational School of Nisporeni:**

The refurbishment project documentation (including bill of quantities and design project) were ready in Q4 (due to detected additional complexities relating to microwinery production sections, additional need to include a sale point etc., the final design for construction of the annex came with delay). But During Q1, PIU could not proceeding to launching a tender to select the general contractor who will perform the civil works because it is envisaged to combine also the FB Vocational school Nisporeni, which was not ready in the q1 due to new modification solicitations. This task is re-scheduled for the

second quarter.

# Q-2

### **Technical University of Moldova:**

During Q2- 2017, PIU has finalized implementing 2 contracts signed under Shopping #FURN\_UTM3\_2017 (2 Lots) for procuring laboratory furniture (including exhaust niches with accessories) for the last laboratory to be endowed — Laboratory of Chemistry, within Oenology Department, TUM. The requested goods were split into 2 separate lots: Lot 1 — exchaust niche with accessories; fire proof closet and Air Conditioning system; Lot 2 - Laboratory furniture;

During Q2, PIU has received a draft document on technical specifications from TUM, on procurement and further endowment of University lab rooms with Chemical reagents, laboratory equipment and accessories to existing lab equipments. It is envisaged that the final list of goods and technical specifications will be ready during Q3, and the tender will be lunched at beginning of Q3. With this last procurement, PIU estimates to fully finalize the implementation of the 3<sup>rd</sup> investment project of TUM.

### **Vocational School from Leova:**

During Q1 and Q2, the PIU, together with previously selected architecture design company, the Beneficiary and PIU experts has worked towards optimizing the volumes/schedules of refurbishment works that will be contracted during Q3, for the respective microwinery laboratory. The works that will be contracted during Q3 consist of capital refurbishment of existing microwinery hall. The PIU shall launch a National Competitive Bidding procedure at beginning of Q3 to select the general contractor who will perform the civil works. PIU envisages to have all construction works finished till end of Q4, 2017

# **Vocational School of Nisporeni:**

During Q1 and Q2, the PIU, together with previously selected architecture design company, the Beneficiary and PIU experts has worked towards optimizing the volumes/schedules of refurbishment works that will be contracted during Q3, for the respective microwinery laboratory. # Q-3

# **Technical University of Moldova:**

During Q3- 2017, PIU has launched a shopping procedure #LAB\_UTM3\_2017 (3 Lots) for procuring New laboratory equipments, accessories to existing lab equipment and chemical reagents for didactic purposes, all for Oenology Department, TUM. Based on the received price quotations (1 bid for each of the 3 lots), based on little participation of potential bidder, and based on the fact that the submitted bids were significantly above the estimated budgets, the Bids Evaluation Committee, together with TUM, have decided to cancel this procurement, revize the initially requested quantities of goods and revize/simplify the initially requested technical parameters for certain goods. On Sept 22, 2017, the shopping was re-launched, deadline for bids submission being October 05, 2017 (Q4). It is envisaged to sign the supply contracts in October and manage to finalize contracts implementation till end of Q4, 2017.

With this last procurement, PIU estimates to fully finalize the implementation of the 3<sup>rd</sup> investment project of TUM.

Till end of Q4, the signed contracts have been partially implemented by contracted Suppliers. It is envisaged that by end on January 2018, both supply contracts to be fully implemented.

With this last procurement, PIU will be fully finalized the implementation of the 3<sup>rd</sup> investment project of TUM.

# **Vocational Schools from Leova and Nisporeni:**

During Q1 and Q2, the PIU, together with previously selected architecture design company, the Beneficiary and PIU experts has worked towards optimizing the volumes/schedules of refurbishment works that will be contracted during Q3, for the respective microwinery laboratory. The selection process for implementing the respective works has begun in Q3 within a National Competitive Bidding for capital refurbishment of existing microwinery hall. On sept 14, 2017 took place the public opening of bids and evaluation process lasted till beginning of Q4, including contract signing. The general Contractor, who was selected, began performing the respective refurbishment works during Q4. It is envisaged that the refurbishment works to be fully finalized (depending on weather conditions) till beginning of Q2, 2018.

# **National Center for Alcoholic Products Testing (CNVCPA)**

During Q3, out of remaining investment project proceeds, and based on the identified by CNVCPA needs, PIU has requested from previously selected and contracted Supplier of programming technical services – introduction of further functionalities to previously elaborated Information System. The IT Company was contracted for additional programming services by the end of Q3. The respective contract was finalized by end of Q4, 2017. With this last procurement, PIU was fully finalized the implementation of the CNVCPA investment project.

### A2. Assisting the newly identified potential beneficiaries in investment projects development, during 2017:

At beginning of 2017, the new investment project – Creating a Center of Excellence within the Vine and Wine College from Stauceni has been re-launched. During Q1, the MoAFI Working Group has approved the investment project based on the feasibility study report. At the beginning of Q2 of 2017, PIU prepared the

Eligibility Note and sent the project to EIB for review and Non Objection approval. During the visit of the EIB representatives in Moldova (03-04 May, 2017) a special attention was brought to the discussions regarding the particularities regarding this project, including several meetings on this subject with Vice Minister Vasile Luca. However, during the next period of the year no progress has been registered due to the fact that the project implementation was directly constrained by the extension of the "Filiere du Vin" Project.

The Investment project with an estimated budget of 2.7 mln euros from EIB Funds, includes the renovation of the main study building, pupils dormitory, canteen and establishing 2 ha of wine grapes and a processing micro-winery, as well as its endowments, which made it impossible to be implemented before December 31st 2017, the remaining period of the FdV project. During the Q2, the PIU together with the local authorities prepared the necessary documents requiring an additional of 2 years of extension of the Program. The official letter has been sent to the EIB during Q3 but no decision has been issued since the end of the year, therefore the project remained on hold, its implementation being possible only in case of an eventual extension of the "Filiere du Vin" Program.

In July 2017, the National Office of Vine and Wine from Moldova (NOVWM) together with PIU has started the discussion on the possibility of the NOVWM on accessing financing from EIB sources. NOVWM is a public institution established by the former Ministry of Agriculture and Food Industry, now the Ministry of Agriculture, Regional Development and Environment, authority which is responsible for creating and promoting the national wine brand. From the preliminary discussion the Office intends with the support of the EIB sources to develop the promotion and visibility of the National Wine Brand, through investing in equipments and goods and for raising the visibility of the wine training consumption and promoting the Wine Brand itself. The planned investments were to create several pop-up containers which will be used as mobile stands for local and international exhibitions, festivals and other public events. The investment project required short term implementation due to the constraints linked to the implementation period of the Program. Due to the fact that by the end of Q3 the sub-project was not submitted yet to the PIU there is no possibility to implement it until the end of the year. Therefore, the discussions will be resumed only in case of extension of the Program.


